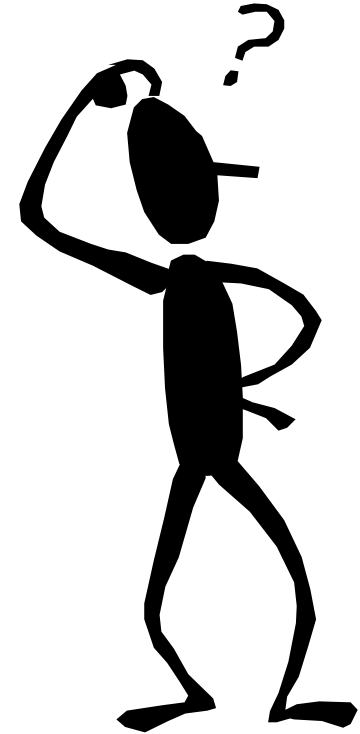

## **WHAT IS MAT?**

---

The MAT consists of 120 partial analogies. Students are given 60 minutes to complete the test, and per MAT policy, all students must stay the entire 60 minutes. Detailed information can be accessed on the web at [www.milleranalogies.com](http://www.milleranalogies.com)

## **HOW DO I REGISTER?**

---

At FPU, no registration is required. You will need to contact the FPU Test Center for room assignments and retest requirements.

## **WHAT DO I BRING?**

On the day of the test, arrive 15 minutes early with a photo I.D. and a check or money order payable to "Fresno Pacific University" or "FPU."

## **FPU COST**

---

Cost per exam is **\$50**. (Fees subject to change.)

## **WHEN WILL I RECEIVE MY SCORE?**

You should receive your official score report approximately 10-15 business days after you take the test. A preliminary score report will be printed the day of the test. *Please note that during the holiday season, test results may be delayed.*
