- Completed Application
- Overall GPA of 3.0 or better (Letter of petition for students with a GPA under 3.0
- Personal and professional aptitude
- Submission by priority deadline (later applications are considered as space permits & are taken on rolling basis)
- *Advanced Standing This pertains to applicants who have graduated from Council on Social Work Education (CSWE) Bachelor of Social Work (BSW) accredited program. Applicants may be eligible to begin the MSW program in year 2 of the curriculum.
 - Must have completed a verified 400+ hour internship.
 - Advanced Standing (Year 2) offering will begin in Fall 2024.

Applicant Instructions: Please answer the following questions in 3-5 pages using narrative form. Applicants should utilize APA format with a cover page, double space, Times New Roman, and 12-point font. Your response to the scholarship questions should be submitted with your MSW Program Admission Application.

The MSW scholarship focuses on behavioral health and helping children, youth, and families in underserved communities aimed at wellness, recovery, resilience, and empowerment. With this in mind, please answer the following questions.

- 1. How has your connection with an underserved community influenced your decision to pursue an MSW?
- 2. How do you anticipate using your MSW degree focusing on behavioral health to help others?
- 3. Identify and discuss at least two critical areas impacting behavioral health/mental health services within underserved communities.
- 4. Behavioral health social workers serve clients in various multidisciplinary settings and can be the sole social worker on the team. What strengths could you bring to an environment like this, and what growth areas do you still want to develop?
- 5. Explain your understanding of culturally competent practice. What would you consider your areas of strength and areas of growth working within this framework?
